On August 7th 2023, Governing Board meeting of MBC took place at the Catholicate office at Devalokam, Kottayam.

The meeting was presided over by His Holiness Baselios Marthoma Mathews III, the President of the college, and it commenced at 3PM with a prayer led by His Holiness.

During the presidential address, His Holiness urged everyone to collaborate for the advancement of MBC college.

After the Director read the previous minutes of the meeting, it received unanimous approval. The proposal to pass the minutes is mentioned by Rev. Fr. Mathew Varghese and seconded by Dr. David K. Daniel.

Initially, the annual audited accounts of 2022-23 were presented by the Director and were approved by the Governing Board. Mr. Josi Thomas proposed it and Fr. Gigi Varghese seconded it. The Governing Board commended the MBC Team for substantial improvements in the financials of the college.

Subsequently, the following decisions were made after discussions:

1. The decision was made to advertise in newspapers for admissions to the lapsed seats and to admit students in management seats without requiring an entrance exam.

2. It was decided to organize more industrial visits.

3. The placement cell should offer additional internships to students.

4. Faculty members were encouraged to take the initiative to identify companies for site visits in their respective departments. A nominal incentive to be provided to faculty members who arrange such visits.

5. A presentation of M-Hive Incubator was arranged and it was decided to proceed with its possible implementation for the benefit of the students.

6. Programs for the skill development of the students should be organized.

7. The decision was made to promote MBC programs maximum through social media.

8. Due to lower student intake in Civil, Mechanical and Electrical branches, steps to be taken to reduce the intake from 60 to 30. No branches should be discontinued entirely at this time.

The meeting adjourned at 5:30 pm with a prayer and benediction led by His Holiness. Subsequently, the next meeting, originally scheduled for September 1st, was cancelled.
